GAZETTE NOTICE

ESTABLISHMENT OF SAFETY ZONE FOR ENI GHANA LIMITED

WHEREAS under paragraph (a) of subregulation (1) of regulation 1 of the Ghana Shipping (Protection of Offshore Operations and Assets) Regulations, 2012 (L.I. 2010), the Minister responsible for Transport may establish a safety zone around an offshore installation to protect the installation either installed or being installed on the seabed within Ghana's maritime jurisdiction;

WHEREAS under subregulation (4) of regulation 1 of the Ghana Shipping (Protection of Offshore Operations and Assets) Regulations, 2012 (L.I. 2010), the Minister shall define the co-ordinates of latitude and longitude of the safety zone established in respect of a floating offshore installation under subregulation (1) of regulation 1;

WHEREAS under subregulation (1) of regulation 1 of the Ghana Shipping (Protection of Offshore Operations and Assets) Regulations, 2012 (L.I. 2010), the Minister shall publish in the *Gazette*, a notice of establishment of a safety zone around an offshore installation;

NOW THEREFORE, I, HON. KWAKU OFORI ASIAMAHA, Minister responsible for Transport do give notice of the establishment of a safety zone for ENI GHANA LIMITED with the co-ordinates of latitude: 04° 28' 09.678" N and longitude: 002° 33' 12.140" W.


**IN THE MATTER OF STATUTORY DECLARATION BY EUGENE NII
